Testimony

Kahakumu, kane, sworn (same witness as in Waiapuka) Niulii is bounded on the Hilo side by Waiapuka. On the mauka end by Kehena, On the Kohala side by Makapala, and makai by the sea. The land has free fishing rights.

Cross-examined.

Testimony closed

Mr. Woods stated that he has no other witnesses than have been already examined on Waiapuka, and asks to have boundary Certificate issued in accordance with decision of Waiapuka, certificates of Boundaries of Kehena and Makapala.

Ulupaalua Ili in several pieces in Niulii, Kohala, bounded. The surveys of the above made by Kaelemakule, and the notes of the surveys of all except Keei, are in the hands [page 226] of S.C. Wiltse, who will act on Akahi's behalf in the settlement of the boundaries. Akahi's husband, Kapaa, may be in Kona, either it [at or in] Kealia or Keei, when you go there. Please enquire for him, and let him know what you have to do, so that he may assist you if possible. He may have the notes of survey of Keei.

The remark upon the quality of the lands in Puna and the necessity for avoiding all expenses not absolutely necessary will apply also to these Kona lands, also especially to Makalawena. A few acres more of [or] less of aa on pahoehoe is not worth disputing about.

Testimony

Kaukaaha, kane, sworn, I was born at Niulii, Kohala at the time Kamehameha II sailed for London, and I have always lived there. Know the land of Ulupalua. My father, Pupule (now dead) showed me the boundaries at the time he had charge of it. Bounded on the Kohala side by the land of Makapala; the boundary between the konohiki part of Niulii and Ulupalua is at a place called Waikane; Ulupalua being on the mauka side of the iwi aina between this place and Niulii. The iwi aina runs towards Waipio, mauka to an ili aina called Paimilu; thence mauka to the makai part of Kahaa, owned by my Father, or corner where his land and Ulupalua join; Thence bounded by the land of Makapala to place of commencement.

There is a portion of Ulupalua in the ferns below the woods.

Bounded on the East side by a portion of Niulii called Puakane, there being an iwi aina between the two; bounded on the mauka side by a lele o Waikane and on the makai side by lele o Kahaa. On the mauka side of this land there are piles of stones erected at the corners. Elemakule surveyed Ulupalua, and my father pointed out the boundaries to him. These are all the boundaries of Ulupalua, and I can point them all out.

Cross-examined.

Awoepaka, kane, sworn, I was born here in Kohala at the time of Kiholo. I now live on Niulii, went there several years before Kamehameha III died. Know the land of Ulupalua. The last witness and a man named Paona, told me the makai part. But I do not know the mauka one. The makai one is bounded mauka by the Ili of Kahaa, makai by Waikane and on the Kohala side by Makapala, and Paimilo on Hilo side. There is an iwi aina all around it ~~on the Hilo side~~ I found this out when Kuakini surveyed it. There is a rock close to the pali at Waikane. This is all I know of the boundaries.

Cross-examined.

Naiapaakai, kane, sworn, I was born here in Kohala and have lived here over forty years of my life. I am kamaaina of Ulupalua; and became acquainted with the boundaries of it when I leased Niulii. I went with Kaukaha kane, Paalau kane, and Manuia kane and found out both portions of Ulupalua as it is an ili aina of Niulii, but belongs to a different owner, and I wanted to know what land was leased to me, and what was not. Makapala bounds it on the West; the boundary running along the brow of the pali. There is an iwi aina on the makai side between this land and Waikane; thence towards the East to another ili aina that [page 124] turns mauka along said iwi aina to Kahaa; the iwi aina is very distinct. Kahaa is sold to natives; thence along Kahaa to Makapala. The other portion of Ulupalua is above Kahaa, bounded makai by ~~by~~ Kahaa and on the other sides by Konohiki lands. There are no distinct boundary marks to Ulupalua mauka. There are some kalo patches said to be on Ulupalua, but some of the other boundaries that were pointed out, I cannot vouch for. There are water springs near the mauka boundary, but I do not know the names of them; I have never heard of any dispute about the boundaries, but have heard some dispute about the springs.

I lease Niulii now.

Testimony on the part of the applicant

Kaiama, kane, being duly sworn says, I was born on Maui. Have lived on Waiapuka,
North Kohala about 19 years. Moved there several years before the time the small pox

was prevailing. Know the boundaries of Makanikahio 2d. I went with Curtis Lyons when he surveyed Makanikahio 2d[?], and the old people pointed out the boundaries. I went with the Kamaainas when Mr. Wiltse surveyed part of Makanikahio 2d. A man named Kili pointed out the lines. Kahena was previously surveyed and they went up to that point. There is a tree about a fathom [page 44] makai of the boundary of Kehena. The boundary of Makanikahio 1st runs above Kehena to a small hill, at the intersection of Makanikahio I, Kehena & Pololu. Thence from the land of Kehena along Pololu, to a swampy place, where they plant food; Thence near to a place called Kalaiike; thence half way down the pali - the upper part of the pali belonging to Makanikahio 1, and the lower part to Pololu; from thence to the sea along the center of the pali. The sea is on the makai side of the land. A little before you reach the shore you come to a large stone called Kanamakaohua, on the makai side of the Government road. At the shore there is a stone marked X, and a large Puhala tree.

Cross-examined

Keakapua, kane, sworn, I live on Pololu in North Kohala, Hawaii. Was born there at the time of the Epidemic known as Dysentery. I know the boundaries of Makanikahio 1st bordering on Kehena & Pololu. There was a god of Kamehameha 1st that was taken around, and it was set up on the stone called Kanamakaohua. I saw it placed there, and the old people living on the land pointed out the boundaries. Kehena is on the mauka side of Makanikahio 1st. There is a stone at the mauka intersection of Makanikahio 1st & 2d and runs between the places called Kamaole and Hepui. The boundaries were pointed out to keep us from trespassing on Kehena. The Kamaole belonged to Kehena, and Hepui to Makanikahio 1st and Pololu. Thence the boundary leaves Kehena and runs along Pololu to the top of the pali. The level land belongs to Makanikahio 1st and the pali to Pololu. Thence along the top of the pali to the stone called Kanamakaohua by the Government road, from this stone it runs to the sea shore, and is bounded on the makai side by the sea.

Cross-examined

Nahea, kane, sworn, I went with Kelemakule when he surveyed Makanikahio 1st. I am a kamaaina of the land. I was born at Kawaihae, and have lived on Pololu over 20 years. The old folks living on the land have pointed out the boundaries to me. I do not know the boundary between this land and Kehena. Know the boundaries between Pololu and Makanikahio 1st. Waiea, now deceased and the last witness were the ones that showed me the boundaries. They went with Kaelemakule when he surveyed the land. Going mauka from Kalaiiki the boundary between Pololu and Makanikahio 1st leaves the pali, and runs up on to the level land, up to Kehena. When Kaelemakule surveyed the land he went along the center of the pali, until he came to the stone called Kanamakaohua; from this stone the boundary runs to the sea shore, near the top of the pali. The pali belongs to Pololu. Kauka went with the surveyor[?].

Cross-examined

S.M. Kaelemakule, kane, sworn, I am a surveyor, I surveyed the land for Kupa in 1856. Nahea went with me and other people who are now dead. [page 45] Kuuku and Kalama went with me. Kalama is dead. They pointed out the center of the pali as the boundary from the stone called Kanamakaohua running mauka, until you come to a gulch where the water flows from the level land over the pali; from this point the boundary between Pololu & Makanikahio 1st runs up on the level land until we reached the land of Kehena. I made notes of survey on the Pololu side from the points as described by the Kamaainas. My notes of survey commence at a large stone near the gulch that runs down into Pololu.

Cross-examined

Adjourned to Mana, Hamakua to give Crown Commissioners an opportunity to procure witnesses. Before the adjournment Royal Patents No. 1103, 1104, 1105, 1102, 1101, and 2806 were filed, covering the boundary between Makanikahio 1st and 2d.

Mana, Hamakua, April 26th, 1871

According to adjournment the testimony for the Crown Commissioners came on to be heard.

Kanainui, kane, sworn, I was born on Waiapuka, Kohala, Hawaii. I live there. Was born in 1832. I know the boundaries of Makanikahio 1st. Kaili and Kawili pointed them out to me. Kawili is dead. Pololu has one side of the and, Auau 1 on the mauka side and Makanikahio 2d on the other side, and on the makai side the sea. The stone, Kanamakaohua, is on the pali, just above the Government road. You can see the sea shore from this rock. There is no particular mark at the sea shore, to mark the boundary between Pololu and Maakanikahio 1st. From the shore the boundary runs along Pololu to the rock, Kanamakaohua, thence along the pali in a little depression near the top of the pali. All of the pali below this point belongs to Pololu. The name of the place that the boundary goes on to the top of the pali is called Kaapakea. It is a small mound with rocks sticking out of the ground, right on the edge of the pali. From there, it runs mauka along the brow of the pali, until you come to a stone wall named Auau, the line runs on the left hand side of the wall as you go mauka. The line follows the brow of the pali until you come to the wall. At this point it leaves the brow of the pali, and runs up an old road until you come to a place called Nanaku where they plant kalo. The whole of this swamp belongs to Makanikahio 1st. Thence to Waiakalei, thence to a gulch and runs up the gulch to Kehena.

Cross-examined.

Testimony closed.

Decision

It appearing to my satisfaction that Mr. Kaelemakule in surveying the boundary between Makanikahio 1st and 2d did not follow the notes of survey as given in Royal Patents Nos. 1103, 1104, 1005, 1102, 1101 and 2806, and that he included a portion of the land of Pololu in his survey; I hereby order a new survey of the land of Makanikahio 1st to conform to boundaries as fixed by the above mentioned Royal Patents, and from the stone marked P. at the intersection of the boundaries of Makanikahio 1st, 2d and Kehena as fixed by Royal Patents No. 2806, run along the line of Kehena, between the places called Kamaoli and Hepui, to a small hill on the mauka side of Hepui, at the intersection Makanikahio 1st, Kehena and Pololu; Thence towards the shore along Pololu to a place called Waiakalei; thence to a swampy place called Nanaku (the Nanaku belongs to Makanikahio 1st); Thence follow an old road to the right hand of a stone wall on the brow of the pali called Auau; Thence along the brow of the pali to a small mound with rocks sticking out of the ground called Kaapakea; thence along a small depression near the top of the pali to a large rock by the Government road called Kanamakaohua; thence to the sea shore; thence along the sea shore to the boundary of Makanikahio 2d, as fixed by Royal Patent No. 1103.

And notes of survey to be filed in this office previous to the Certificate of boundaries being issued.

And I hereby decide that the above mentioned boundaries are the boundaries of Makanikahio 1st situated in the District of North Kohala, Island of Hawaii, 3d Judicial Circuit.

On this, the fifteenth day of April A.D. 1873, the application of C.R. Bishop, for the settlement of the boundaries of the Ahupuaa of Makapala, District of North Kohala, Hawaii, came on to be heard before the undersigned Commissioner of Boundaries for the 3d Judicial circuit, after notice personally served on the owners of adjoining lands or on their agents.

Present: S.C. Wiltse on the part of C.R. Bishop, the applicant, James Wood for H.B. Jackson and D.K. Naiapaakai for Her Excellency, R. Keelikolani; Deed of Aamakao from His Majesty, Kamehameha IV, bearing date of December 1, 1858, and recorded July 6th 1859, Liber 12, pages 23d and 24th filed for boundary between Makapala and Aamakao.

S.C. Wiltse read the petition of the applicant in the following words;

Honolulu, April 1st 1873

R.A. Lyman, Esquire, Commissioner of Boundaries &c, &c., Hawaii

Dear Sir:

The undersigned, acting for His Majesty, the King, would respectfully ask that the boundaries of the land called Makapala in Kohala, Hawaii, may be defined and settled.

The survey of said land and the notes of the same are in the hands of S.C. Wiltse, of Hamakua, who will attend at the hearing and act for the King. The land of Makapala is bounded on the east by Niulii, and on the west by Aamakao, both belonging to His late Majesty, Kamehameha V. Mauka by the land called Kehena, and makai by the sea.

Testimony for applicant

Kaohe, kane, sworn says, I was born at Waimea, and brought up on Honoaula, and have since then lived on the lands of Aamakao and Makapala in Kohala Hawaii. I was born when Kamehameha I was preparing to go to Oahu, the year before the Peleleau came to

Kawaihae. I am a kamaaina of Makapala, and know the boundaries of the land. My parents who are now dead, showed me the boundaries of the land. Makapala is bounded on the east side by the land Niulii, Kehena mauka, Aamakao on the north side, and the sea on the makai side; the fishing ~~rights~~ grounds belonging to Makapala in old times estended [sic] out into the sea about as far from the shore as from where we are now to the top of that hill (pointing to a hill about half a mile distant). Outside of the Makapala fishing grounds the sea belonged to other lands. [page 86]

The point at the sea shore called Kananaanaka is the boundary between the land of Makapala and Niulii; Thence the boundary between these two lands runs mauka along old iwi aina to place called Keawehala, to the north side of this place. Keawehala is on Niulii. Thence mauka along iwi aina to a Puuhala tree at place makai of the Government road called Painahala: At this point the boundary turns ~~in~~ towards the gulch and runs into it at the bridge, over the stream on the government road; From the bridge it runs to a ridge between two gulches and runs up the ridge. Kamakaumoku on Makapala and Ulupalua on Niulii. Thence mauka on upper side of hau grove; The hau trees are on Makapala. The land above the brow of pali belongs to Niulii. Thence up to place above brow of pali to a place called Palikui, where one pali is right on top of the other; Thence along near the brow of the pali kahawai, Makapali taking in a little of the level land above the pali between place on Niulii called Kamehame, and place on Makapala called Kopalapala; The boundary then turns toward the west for a short distance. Thence mauka near brow of pali to stream; thence across the gulch to place called Paea to a ridge between Kipuhaiole on Niulii and Makaanaihe on Makapala to side of old fish pond called Kilohi; Thence up to east side of Haleolono hill; Thence up old road to place called Kaloapapa at the pali of a kahawai; Thence mauka to place called Kalapaliolio, the mauka corner of Niulii; Thence easterly to kahawai Aemoku; thence mauka to Hooheehe where Kehena cuts Makapala off. I went with Brother-in-law of Austin when he surveyed this land. Puanaiwi was a kamaaina of Niulii, and went with us at that time. The boundaries I have testified to today are the ones Puanaiwi pointed out to Mr. Sleeper, and are the ones he surveyed to, in surveying Makapala.

Cross-examined

D.K. Naiapaakai, kane, sworn says: I was born on the land of Kalala in North Kohala May 8th 1819[?]. Have lived in Kohala most of the time since then, and am a kamaaina of Niulii. I have held the lease of Niulii the past five years. When I leased the land I got Puanaiwi, Kukeanui, Kapaaha[?] and Palau, kamaaina of Niulii and Makapala, to point out the boundaries of Niulii, and between Niulii and Makapala. Puanaiwi is now dead. A point at the sea shore called Hanakaka is the boundary between Makapala and Niulii. The boundary from this point between these two points runs mauka along iwi aina to Puhala tree at place called Painahala makai to Government road; There the boundary turns towards the west and down into the gulch, to loi makai of the bridge across the stream.

Two gulches unite here, and the boundary runs up the ridge between the two gulches, and follows up an old trail near the brow of the Makapala gulch to Kaipolii's house; There the old trail comes to brow of pali and along the brow for a few fathoms, and then runs along

trail having the pali a short distance from the trail to Kaneihala's kuleana on Niulii. The west side of this kuleana was pointed out to me, as the boundary of Makapala; Thence mauka near the brow of pali of Makapalai gulch, to Paipai gulch, cross the Paipai gulch, and along close to brow of pali passing one side of place called Kipukaiole on Niulii [page 87] and along up the ridge to a small artificial fish pond; Thence to the left side of a hill; I do not remember the name of it; Thence mauka along old trail to place called Kaloapapa on the pali of the Makapala gulch; Thence mauka along brow of the pali kahawai to Kalapaliolio, the mauka end of Niulii. Thence along land of Kehena, up along and across the gulch to Papa pahoehoe, where Kehena cuts Makapala off. The sea is on the makai side of the land of Makapala. The fishing grounds belonging to land in olden times, extended a good distance out to sea.

Cross-examined

S.C. Wiltse, sworn says, The notes of survey and plan of Makapala filed, were received from C.R. Bishop in a letter from him dated March 22d 1873.

Testimony closed.

Notes of survey of Makapala compared with notes of survey of Kehena 2d and notes of survey in deed of Aamakao and found correct.

Decision

In re Settlement of Boundaries of Ili aina Pa-u, Ili of Pololu<strike>I</strike>, District of North Kohala, Hawaii.

The hearing was advertised to be held on the 12th day of December 1898 at the Court House at [page 232] Kapaau, North Kohala, Hawaii.

Note: the Commissioner of Boundaries for the Third Judicial Circuit, Hawaiian Islands was detained at Hilo, Hawaii, and unable to attend the hearing and authorised [sic] C.H. Pulaa, Notary Public, 3d Judicial Circuit to take the evidence of the witnesses as to the boundaries of Pa-u, if any of the witnesses are too old and feeble to go to Hilo to give their evidence.

At 10 a.m. December 12, 1898, there appeared at the North Kohala Court House before C.H. Pulaa, Notary Public, 3d Judicial Circuit, A.B. Loebastien and H.L. Holstien for the Petitioner, and brought with them Kauai, wahine, Kupukaa, kane, Meheula, kane, and Pupuka, kane and others.

No one appeared for the Republic of Hawaii, the owners of the Ahupuaa of Pololu.

A.B. Loebastien asked to have the evidence taken by C.H. Pulaa, Notary Public, as authorised by the Commissioner of Boundaries as Kauai, wahine is old and feeble, and not able to go to Hilo, Hawaii.

Kauai, wahine, sworn, My name is Kauai. I live at Pololu and have been a kamaaina of land from my childhood. I am about 68 years old.

I am a real kamaaina of land of Pa-u. My Grandparents and Parents showed me the boundaries of land. It is situated at Pololu, North Kohala, Island of Hawaii. They were Kahu of the Chiefess Kamae, mother of Keohokalole, the mother of Kalakaua and others.

Probably, the land belongs to Kauilani now. I have no doubt about the boundaries of Pa-u. I saw land surveyed by A.B. Loebenstien on the 28th of November 1898. I and my children went with him, and told him the correct boundaries of the land.

We commenced to survey at place at shore called Pohakukumaka at Kona side at makai corner at foot of Pololu pali.

I pointed out Pohakukumaka; From [page 233] this point boundary runs to place called Lokoula; From Lokoula run along sand beach toward Hilo to Puuko-a on sand beach, the corner toward Hilo; From Puuko-a run mauka to Kahikiwalea, a ridge and ahua; Thence mauka to Waiakapuaa, at the place where the Loi (kalo or rice patches) commence, thence boundary runs to Pele; thence to Painanui to mauka corner of Pa-u. Place called Kanekuku on the Ahupuaa of Pololu joins this place. Painanui is on the Ili Pa-u. From Painanui boundary turns toward Kona.

The surveyors compass was set up at each one of these places. From Painanui boundary runs to Lania, a kukui tree where Surveyor's compass was set up, and from this point one sighted to poles until came to Kahaakea, the corner toward Kona; From Kahaakea boundary runs makai to Paeloa; From Paeloa runs makai to place of commencement, Pohakukumaka. Surveyor went around with us. Land of Pa-u always had ancient fishing rights extending out in the sea to the other edge of the breakers.

All the points on the boundary of Pa-u that we pointed out to Surveyor, are the boundaries that were showed to me by my Grandparents and Parents. What I have testified to today is the truth.

Pupuka, sworn, My name is Pupuka, was born at Pololu, and am 36 years old. Am a kamaaina of this land Pau; it is in land of Pololu, District of North Kohala. My house is on the Ahupuaa Pololu, near boundary of Pa-u.

My Parents and Grandparents showed me boundaries. Land of Pa-u belongs to the Chiefs, Kalakaua and others. I and my parents [page 234] have cultivated food on Pau. The Surveyor came to survey the land on Monday the 28th of November 1898.

I went with Kauai, wahine, Kupukaa, kane and Meheula, kane.

We commenced to survey the land at the corner toward Kona at Pohakukumaka, a rock in the sea. My parents told me this rock was called Pohakukumaka. From there we went along sea shore to Puuko-a, the Eastern corner of land on the Hilo side at sea shore. From there turned mauka and ran to Kahikiwalea, a sand hill (or mound); From there went to

Waiakapuaa, and from thence to Pele; From thence to Painanui, that is Kanekuku, the mauka corner on Hilo side of Pa-u; From thence turned toward Kona to Lania, a kukui tree; From there to Kahaakea at the base of the pali, the mauka corner of land on Kona side, surveyed by sighting to sticks set up. From Kahaakea went makai to Kalehelehekii, mauka of my place. Thence to Paeloa; Thence to place of commencement, Pohakukumaka.

I went with the Surveyor, A.B. Loebenstien to all these points on the boundary and are the boundaries of the land that were showed to me by my Grandparents and Parents.

The ancient fishing rights belonged to Pa-u and not to the Ahupuaa Pololu.

There are a great many old loi kalo patches) on Pa-u. the survey made November 28, 1898, was the same boundaries as pointed out to me by my Grandparents and Parents. The evidence I have given is the truth.

The map of Pololu was then showed to witness, and he pointed out on the map, all the places surveyed to.

We commenced to survey at Pohakukumaka, and ran along sea beach toward Hilo to Puuko-a; thence mauka to Kahikiwalea; thence to Waikapuaa; Thence to Pele; Thence to Painanui; thence toward Kona to Lania; Thence set up sticks and sighted to them to Kahaakea; Thence toward sea shore to Kalehelehekii, and Paeloa and on to place of commencement, Pohakukumaka. Kauai, wahine is the one who showed me boundaries. I wa not born there. My evidence is the truth.

Loebenstien survey Pa-u on the 28th of November 1898. Am a kamaaina, and was one of those who pointed out the boundaries the day survey was made. I showed him Pohakukumaka. Am a kamaaina of that rock, also of Puuko-a,

Kahikiwalea is a sand hill (or mound). Know Waiakapuaa, Pele, Painanui, Kanekukui, Lania, Kahaakea, Kalehelehekii, Paeloa and back to Pohakukumaka, place of commencement of survey. All these boundaries were marked.

The map of Pololu was then showed to [page 236] witness, and he said this map is like the boundaries we pointed out to surveyor, and that I went to [too] with him on the 28th of November 1898.

Kauai, wahine, is the one who showed me the boundaries of Pa-u. we are the only kamaaina of Pololu. My evidence is the truth.

A.B. Loebastien, sworn, The map and Notes of survey that I have filed with you today, are the Map and Notes of Survey of Pa-u.

I made the survey to the boundaries pointed out by the kamaaina, whose evidence was taken before C.H. Pulaa, Notary Public at North Kohala, Hawaii. I followed the foot of the pali on the Northwest side of the land, and on the Southeast side of land. I followed an old path along kuaauna of old kalo patches or loi, which are not planted with rice. The whole land is in the bottom of Pololu valley. Pupuka lives on Pololu and Meheula on the <strike>Ahupuaa</strike> Ili of Pololu near the boundary. Kupukaa lives on a kuleana in Pa-u, and Kauai lives, I think, with Pupuka. Pupuka lives on Pololu near the boundary of Pa-u.

I found no dispute about the boundaries. There still remains a lele of Pa-u mauka in the Valley, so the witnesses told me.

I should judge that it is about an acre in extent, but I did not think it worth while to look it up, but left it to revert to owners of Ahupuaa Pololu.

The Ahupuaa of Kaauhuhu, North Kohala, Hawaii

On the eleventh day of April A.D. 1873, by adjournment from the 9th instant, the Commission of Boundaries for the 3d Judicial Circuit, met at the Court House in North Kohala. Present: James Woods, D.K. Naiapaapai, James Wight and others. Due notice of the hearing of the application of J.O. Dominis, Agent of Crown Lands, for the settlement of the boundaries of the Ahupuaa Kaauhuhu, and Pololu, situated in the District of North Kohala, and of the Ahupuaa of Honokaia, situated in the District of Hamakua, Island of Hawaii, 3d Judicial Circuit, having been given by advertisement in the Hawaiian Gazette of March 5th 1873, and the Anokoa of March 6th 1873, and notice personally served on the owners of adjoining lands as far as known for the 9th day of April 1873 for the lands of Kaauhuhu and Pololu, and the land of Honokaia, the hearing to be on the 16th day of April, at the Court House in Waimea, South Kohala. The hearings for the lands of Kaauhuhu continued to Puuhui, North Kohala, the 12th day of April 1873 at 12 o'clock a.m. on account of it being very stormy weather, and G.C. Wiltse, Agent for Agent [sic] of Crown Lands not being able to ride through the storm to attend the hearings. The hearing for the land of Pololu was adjourned to Puuhui April 14th at 10 o'clock a.m. the hearing for the land of Honokaia was adjourned from the court house at Waimea, South Kohala on the 16th of April until 10 o'clock a.m. April 18 at the house of J.P. Parker at Mana, Hamakua, Hawaii.

Royal Patents No. 4395, 2390, 2462, 1544, 3001 and 2451 filed as evidence in relation to a portion of the boundaries of Kaauhuhu.

The case coming on to be heard this day by adjournment from the 11th instant. There were present: S.C. Wiltse on the part of the Crown Commissioners and Hawaiian Government, James Woods for H.B. Jackson, P. Kamakaala for Guardians of A. Haalou Ii and others.

Petition read as follows:

The Ahupuaa of Pololu, North Kohala, Hawaii

On this fourteenth day of April A.D. 1873, the boundary commission met at Puuhui, North Kohala, Hawaii, by adjournment from the 9th and 11th instants to take testimony in relation to boundaries of Crown Land Pololu. See application Folios 53 & 54.

Present: S.C. Wiltse on part of Crown Commissioners, and also for Administrators of the Estate of His Majesty, M. Kekuanaoa and the Hawaiian Government; James Woods for H.B. Jackson, owner of Kehena, D.K. Naiapaapai, and others.

S.C. Wiltse stated that the boundary between Pololu and Makanikahio was settled by Boundary Commissioner in April 1871 and certificate of the boundary of Makanikahio was issued in May 1871 and that he proposed to introduce evidence as to boundaries between Pololu and the lands of Honokane on the east side and the land of Kehena on the mauka side to corner of Makanikahio 1.

Testimony

Kuke, Kane, sworn says, I was born on the land of Apuakohau in North Kohala, about three years before the building of Kiholo. Have alway[s] lived in Kohala. Have lived on Honokane 16 years and was the konohiki of it during those years. Mamani and Koko pointed out the boundaries between Pololu and Honokane to me. I did not go with Wiltse when he surveyed Pololu. Mamani went with him and when they returned from surveying the land, he told me what boundaries he had pointed out to Wiltse, and they were the same ones as were pointed out to me, when I took charge of the land. Mamani and Koko were old Kamaaina of these lands. Koko is dead and Mamani is loko, and too feeble to go far from home. There is a pile of rocks on the boundary between Pololu and Honokane at the sea shore (sea side of Pololu) called Kapili; the old house there was called Keawehalau; thence the boundary between these lands runs mauka across the land and awaawa and up the pali to Kupiha; thence along the brow of the pali, the side of the pali towards Pololu all belongs to land of Pololu, the land on east side of brow of pali to Honokane. Thence to place called Keikepuaa; thence to place near the woods called Paa;

Thence up pali in woods passing Haoi (an ili of Pololu[]) running up the pali to a hill called Puukana; thence to Kaohumauna; along sharp ridge Pololu one side Honokane the other to place on level land mauka of Pololu pali called Kaneaa, where Kehena 2 joins Pololu and Honokane at Honokani pali. I do not know the boundaries between Pololu and Kehena 2d.

Cross-examined. [page 60]

Palau, kane, sworn says, I was born on the land of Halawa before the Kuikalani, in Kohala, Hawaii. I am a kamaaina of Kohala and know the lands of Pololu, Honokane and Kehena 2d. I used to collect olona on Pololu and Honokane. I lived on Niulii. When I went after olona on Pololu, I had to pay the konohiki of Pololu for it, and when I went on Honokane, I had to pay the konohiki of Honokane. Have always been told that the pali on the east side of the valley is part of Pololu, and that the land beyond the top of the pali belongs to the land of Honokane. The boundary between Pololu and Honokane runs up the pali, and along near the brow of the pali to place called Kaneaa, the junction of the lands Pololu, Honokane and Kehena 2d. From this point the mauka boundary of Pololu runs along the land of Kehena 2d, following the brow of the pali clear around the head of Pololu Valley to point opposite place called Kalehu, the corner of Makanikahio 1 and Pololu. Thence straight from the brow of the pali to Kalehu (or Kalahu).

I went with Mr. Sleeper when he surveyed Kehene 2d. Paia (now sick at Kawaihae uka) and Kalawaia now in Court, were along with us. We all pointed out the boundaries to him. Hoomana, the konohiki of Niulii went with us when he surveyed across the had of Niulii. Mr. Sleeper surveyed along the line of Kehena 2d and Pololu to the Pololu pali, and then surveyed half way around the head of the Valley. He took sights to Kaneaa, and did not go to Kaneaa.

The level land on top of the pali at the head of Pololu Valley belongs to Kehena 2d, and the whole pali is in Pololu.

Cross-examined

S.C. Wiltse, sworn, I surveyed a portion of the land of Pololu during the year 1872. I surveyed the line between Pololu and Honokane from the seashore to place called Kaneaa on the boundary of Kehena 2d. From this point along the land of Kehena 2d I copied notes of survey of Kehena 2d made by J.H. Sleeper in 1858 to corner of Makanikahio 1 and Pololu on the line of Kehena 2d. From this corner of Pololu, I copied notes of survey as given in Certificate of Boundaries of Makanikahio 1, No. 11 to the sea shore. I surveyed the line between Pololu and Honokane as pointed out to me by Mamani and Kekupua. I am told Mamani is very feeble now, and that Kekupua is in the Oahu jail. The notes of survey and plan of land that I now file, described the boundaries of Pololu, as pointed out by the kamaaina, and as previously established by Certificate of Boundaries.

Cross-examined

Kuke, kane, recalled says, the sea bounds the land of Pololu on makai side. Pololu had an ancient fishing right extending out to uhu fishing grounds. There is a kuono of Pololu on the side adjoining Makanikahio 1 belonging to D. Kalakaua, that owned part of the fishing right. I do not know the boundaries of it.

Testimony closed

Decision

I decide and certify the boundaries of Pololu, North Kohala, Hawaii to be as set forth in the description of Boundaries in the following copy of certificate of Boundaries.
